Elk – Kevin Strozzi made a motion to add a any legal weapon Bull Depredation Hunt in 251 with same season dates for 2018-2019 as were approved for Cow Hunt; seconded by Charlie Cecchini; 4 yeas.

Sheep – Kevin Strozzi made a motion to split Unit 173 between North and South with given boundary Sept 5 – Oct 5 for North, Nov 20 to Dec 20 for South; Unit 161 the early hunt Sept 5 to Oct 5; seconded by Charlie Cecchini; 4 yeas.
