Water District Governing Board Member Dennis Gaddy made a motion to approve the Minutes from the January 29, 2018 Governing Board Meeting. Walt Kuver seconded the motion. The vote was approved 7-0.

Due to the previous noted modification, Savannah Rucker presented the Budget Status Report (see discussion minutes under Item 11. a Finances)

9. (00:08:00) For Presentation – Presentation from Jeff Fontaine, Executive Director, Central Nevada Regional Water Authority (CNRWA) regarding current issues under consideration by the Authority.

Central Nevada Regional Water Authority (CNRWA) is an eight (8) county unit of government that collaboratively addresses issues common to: Churchill, Elko, Lander, Esmeralda, Eureka, Nye, Pershing and White Pine Counties. Land in these counties comprises 2/3 of Nevada's land. There are 78 ground water basins in Central Nevada and almost half (35) are in Nye County.

The CNRWA is involved in 4 main initiatives: Growth, Drought & Climate, Water Quality and Water Management. They are following Order 1293 closely and are also tracking the development of lithium deposits and anti-degradation methods.

Jeff Fontaine also serves as the Executive Director of the Humboldt River Basin Water Authority. Currently, the biggest issue he sees in this capacity, is conjunctive management. The Humboldt River is fully appropriated and our State Engineer is proposing how ground and surface water rights will be managed. As with dealing with all water issues, long-term, future planning (50+ years) is encouraged.

Oz Wichman provided background of the GWMP. It was a result of a Board of County Commissioner's Advisory Committee that met for 21 months and produced the 2015 version of the GWMP. The staff report included in the back-up, highlights items that have transpired since.

The revised February 2018 GWMP considers the land situation (densities that can support a population of 500,000) and water enough to support 80,000. The emphasis is to live within our means, with no importation pursuit. Consideration is given to conservation efforts, RIBS and recharge, attrition and Order 1293, which states that there are to be no more commitments to the water in the Basin. The GWMP also supports improving the Desert Research Institute Model (which has a potential impact on the perennial yield calculations) and discussion on re-distribution of pumping.

The crux of the GWMP is Table 3. The Table highlights water right commitments for future conditions (year 2068). There are 2 changes to the table. Line 9 should read 2,840 (not 2,750), which will change the bottom line number (line 21) to 6,660. As Walt Kuver, Water District Governing Board Member stated, "Table 3 is a very significant table to base future decisions". "In essence, this is the growth control mechanism that still honors all the overappropriated water rights".

Water District Governing Board Member Walt Kuver made a motion to adopt the February 2018 version of the Ground Water Management Plan. William Knecht seconded the motion.

Comments from the Public

John Bosta expressed his concerns over the adoption and revision of the GWMP. He read and supplied a written statement that is attached below.

The INTRODUCTION statement; "In addition, the community of Pahrump has available deeded lands in sufficient amount to support a population of 495,000 is a wet "pipe dream", an unattainable or fanciful hope or scheme. There is not enough ground water.

The overall goal of 198 gallons per person/per day adopted in the 2014 Pahrump Master Plan is 98 million gallons/day which is 35 billion 700 million gallons per year which is 109,876 acre-feet per year which is 6 times the Perennial Yield of 18,000.

This new revisions and/or possible adoption of the Pahrump Ground Water Management Plan (GWMP) will eliminate all domestic well use of water in the Artesian Pahrump Basin 162.

The regulation of land use based on police power is distinct from the taking of private property by the government through the power of eminent domain.

Domestic wells use is real property which the Water District has no power. Eliminating domestic and reducing two acre feet of water to 198 gallons per day is a taking of real property without using the power of eminent domain to compensate a property owner for eliminating the domestic well and reducing 2 gallons per minute which is 2880 gallons per day down to 198 gallons per person.

The adoption of the revisions of the Ground Water Management Plan (GWMP) has no authority of an Ordinance.

The Domestic Well Owner had no representation on the Ground Water Management Plan Committee because their domestic water use is not a Water Right Permit use issued by the State Engineer.

The adoption of the GWMP is not in the best interest of 11200 domestic well owners in the Artesian Pahrump Basin 162 and should not be adopted.

I. FY 17-18 Budget Status

Savannah Rucker summarized the Nye County Water District Fund Balance Report. The Water District received approximately 85% of its revenues in the 1st quarter. Expenditures are at 21% which is rather low, but we do have some encumbrances for contracts. Expenses are in line with projected expenses. No red lines for items being over budget. Salaries, services, supplies and contractual obligations right on track.

Currently Finance is working on tentative budgets. No approval by Board is required for tentative budgets, but the final budgets will need approval between 5/21/18-5/31/18. Next meeting, we will set the Public Hearing date and time for the final budget to be approved in May.

I. Darrell Lacy, Planning Director
Since the Water District Governing Board approved the GWMP, implementation will have to be discussed. Future agenda items will most likely be: water rights dedication for commercial development, and what the Board wants to see as part of future development. Currently, Planning is moving approximately 40 building permits a month (which is double from last year). The GWMP will give Planning a guiding document to work under, as it relates to water usage.
