8. Committee Comments.

Lakeview Executive Golf Course is now a Public Golf Course. It has no management company yet – the group who has been running it before the sale will stay for right now. Open for bid right now with 2 management groups have shown some interest. 4 weeks ago, three greens were open and 1 ½ weeks ago 11 greens are open. Limited moneys are being used right now, but later former airport funds will go to the golf course.

Discovery and Ian Deutch Parks are having people walking the trails. Good idea to have put walking trails in at Kellogg park.

9. For Possible Action – Discussion and deliberation regarding the Fairgrounds. Purpose-To obtain development updates and status and discusses fairground development progress.

Still working on water rights, but getting close to being finished. Tim Dahl, Darren Tuck and Danielle McKee (Nye County employee) have worked on the grant for the drainage study for the fairgrounds. This study will determine the future layout of the fairgrounds. Field area grading of the ground is pretty much done.

10. For Possible Action – Discussion and deliberation regarding the Kellogg Park Development Project. Purpose to obtain development updates and status and discuss park development progress.

Plans for Phase 1, and other park related subject matter. The engineer drawings for the well at Kellogg Park will be completed by the first of July and will be going out to bid shortly after that. 1st stage of grading has been done. Town Project Manager Eddie Martins (24 yr. old with some Engineering studies in college) will be coming to our board meeting, hopefully in July. Eddie is right now separating our plans for bid. The Plans Engineer will still be the final checking on the project, but the project manager will handle the day to day items.

11. For Possible Action – Discussion and deliberation regarding Ian Deutch, Petrack, Simkins, and Blosser parks, etc.

Simkins Park – will get light soon. Budgeted \$450,000.00 for 6 (six) poles outside of the fencing. Simkins is 360 ft. long by 100 ft. wide. This allows for one big soccer field and one small soccer field (for little kids). This field plus our other fields would allow soccer tournament of 26 teams. Lights will shine sum on the basketball court. Lights will also help Pop Warner football, club soccer and baseball (short for baseball field, but great for practice field).

Ian Deutch and Petrack Parks will get shade on the playground equipment - soon. Ian Deutch Park has had field 1 & 2 reseeded plus scoreboard and sound system added.
