

# Workers' Compensation

## Contracted Providers

If an Employee seeks medical attention from a provider not listed below, Nye County *cannot* guarantee ASC will cover any medical expenses or claims filed.

**NRS 616C.020** - Except as otherwise provided in subsection 2, an injured employee, or a person acting on his behalf, shall file a claim for compensation with the insurer within 90 days after an accident if:

- (a) The employee has sought medical treatment for an injury arising out of and in the course of his employment; or
- (b) The employee was off work as a result of an injury arising out of and in the course of his employment.

**NRS 616C.040** - A treating physician or chiropractor shall, within 3 working days after first providing treatment to an injured employee for a particular injury, complete and file a claim for compensation with the employer of the injured employee and the employer's insurer.

**Fatalities/Catastrophic Events:** A Fatality or Catastrophic Event is defined as any on-the-job work-related death, or three (3) or more employees hospitalized (other than treated and released) resulting from the same event. In the event of a Fatality or Catastrophe Event, state law requires that the accident scene remain undisturbed and the State of Nevada Occupational Safety and Health Enforcement Section (OSHES) be notified within eight (8) hours of the event. **Contact: OSHA (702) 486-9020.**
