

1 **NYE COUNTY RESOLUTION NO. 2020-15**

2 A RESOLUTION AMENDING THE DUST CONTROL PLAN FEE SCHEDULE FOR THE PAHRUMP
3 REGIONAL PLANNING DISTRICT

4 WHEREAS, on April 21, 2020 the Board adopted Bill 2020-08 which amended Nye County Code
5 Title 15, Building and Construction, Chapter 15.28, entitled Dust Control Regulations within the Pahrump
6 Regional Planning District, relating to Section 15.28.090, Construction Activities; and

7 WHEREAS, Bill 2020-08 requires the filing of a complete dust control plan with the Nye County Air
8 Quality Program Administrator before initiating certain construction activities, including trenching totaling
9 three hundred thirty (330) feet in length or more, or demolition of any structure(s) totaling five hundred fifty
10 (550) square feet or more; and

11 WHEREAS, the current Dust Control Fee Schedule does not include trenching and demolition
12 activities, and

13 WHEREAS, the proposed fee changes attached herein are necessary and appropriate; and

14 WHEREAS, whenever any such list or fee schedule is promulgated or updated such list or schedule
15 shall by implication supersede any previous application fees whether set forth in a previous fee list or
16 schedule or specific ordinance in any Title of the Nye County Code;

17 NOW THEREFORE, IT IS HEREBY RESOLVED that the fees listed and attached to this
18 Resolution and identified as Exhibit A are now updated and amended, and shall be effective within the
19 Pahrump Regional Planning District; and the fees listed on Exhibit A supersede any previous application fees
20 whether set forth in a previous fee schedule or Nye County Code. It is also hereby resolved that the fees
21 listed on Exhibit A shall become effective on the 21st day of July, 2020.
