Items on the agenda without a time designation may not necessarily be considered in the order in which they appear on the agenda. **NOTICE: It is anticipated that the items of business before the Debt Management Commission on August 19, 2021, will be fully completed on that date. However, should items(s) not be completed, they could be carried over and be heard before the Debt Management Commission beginning at 9:00 a.m. the next day.**

**PUBLIC COMMENT** during the Debt Management Commission Meeting on August 19, 2021, will be for all matters, both on and off the agenda, and be limited to three minutes per person. Additionally, public comment of up to three minutes per person will be heard during individual action items. The Commission reserves the right to reduce the time or limit the total time allowed for public comment. The Commission reserves the right to reduce the time allowed for public comment. The Commission may prohibit comment if the content of the comments is a topic that is not relevant to, or within the authority of, the Commission, or if the content of the comments is willfully disruptive of the meeting by being irrelevant, repetitious, slanderous, offensive, inflammatory, irrational or amounting to personal attacks or interfering with the rights of other speakers. Persons are invited to submit comments in writing on the agenda items and/or attend and make comment on that item at the Commission meeting.

In accordance with Federal civil rights law and U.S. Department of Agriculture (USDA) civil rights regulations and policies, the USDA, its Agencies, offices, and employees, and institutions participating in or administering USDA programs are prohibited from discriminating based on race, color, national origin, religion, sex, gender identity (including gender expression), sexual orientation, disability, age, marital status, family/parental status, income derived from a public assistance program, political beliefs, or reprisal or retaliation for prior civil rights activity, in any program or activity conducted or funded by USDA (not all bases apply to all programs). 5. Review of the Debt Management Policies and Capital Improvement Plans for 2021-2022 of Nye County municipalities.

For Possible Action – Discussion and deliberation to specify a percentage of limitation on the total ad valorem tax levy which must not be less than 75 percent and to also establish priorities among essential and non-essential facilities and services and that public safety, education and health must be considered essential facilities and services, and all other facilities and services must be considered non-essential facilities and services, per NRS 350.0155.
