CALL MEETING TO ORDER

ACTION: Schoen called the meeting to order at approximately 4:31 p.m.

PUBLIC COMMENT AND DISCUSSION

Sharon Wehrly, Nye County Sheriff Candidate, presented the board with literature and a history of experience. Sharon Wehrly informed the board that she has directly overseen high dollar programs within the county. Sharon Wehrly states that there are eight (8) points of concern that she will address and implement if elected for sheriff.

APPROVAL OF MAY 13, 2014 AGENDA

OPEN BIDS FOR JANITORIAL CONTRACT

Beery-Burggraff opened the bids for the janitorial contract. B & B Janitorial proposed \$2,995.00 and Anna Berg proposed \$2,200.00, both monthly rates. Schoen requested that Sweeney obtain confirmation from Anna Berg that the request was correct. Sweeney stated he would request an email from Anna Berg as early as tomorrow. Bob Barber informed the boards that he currently has the insurance required for the position and additional workers in the case of vacation or if he himself would be unable to complete the requirements. Schoen asked if Anna Berg had the requirements necessary. Sweeney informed the board the insurance would not be difficult to obtain can be completed within a day. Schoen suggested that perhaps a decision as to who to hire be tabled to allow the opportunity for Anna Berg to be in attendance to be able to answer questions presented to her in regards to the position.
