5 and shown in the attached Exhibit B is the subject of an offer of dedication to the Nye County Board of
6 Commissioners ("Board"); and

7 WHEREAS, the Board held a meeting on June 05, 2018 and adopted Resolution 2018-18 that
8 accepted the right-of-way described in the attached Exhibit A and shown in the attached Exhibit B; and

9 WHEREAS, the Board finds that it is in the best interest of the County to accept the offer of
10 dedication of the road right-of-way and reject the maintenance.

11 NOW, THEREFORE, BE IT RESOLVED by the Nye County Board of County Commissioners

14 described in Exhibit A and shown in Exhibit B, but rejects the maintenance.

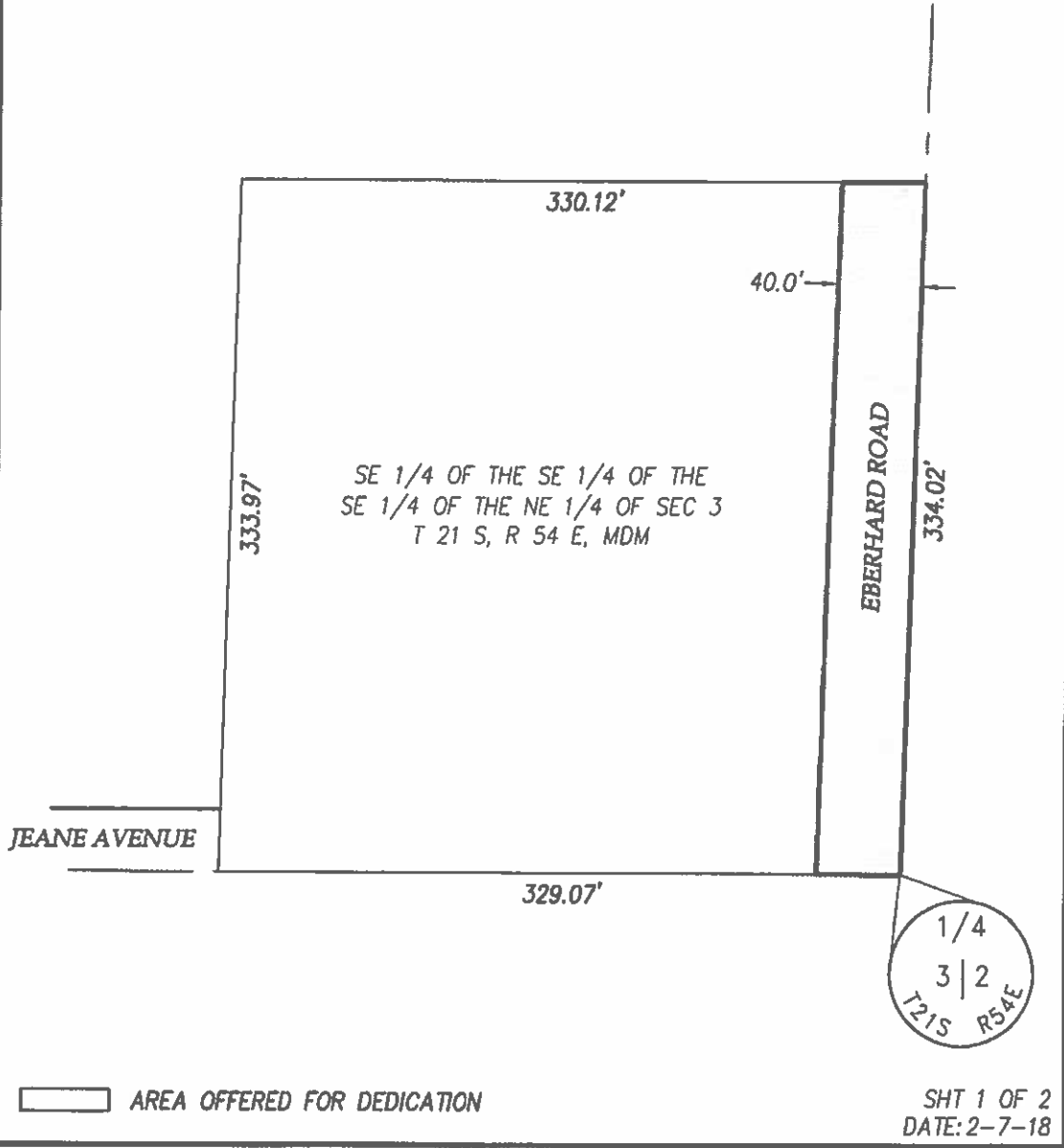
